Tuition and class information:

- Class Tuition is based on the number of weeks of class instruction (not the months). For your convenience, we offer a 10 installment equal payment plan:
 - A one-hour class per week is **\$69 + GST** per month. A 45 minute class per week is **\$59 + GST** per month. A 75 minute class (Acro Acel) is **\$ 79** per month.
 - **Installment 1 and installment 10 are due upon registration.**
 - Registration fees are \$20 per student due upon registration.

Payment information:

- Payments for installments 2-9 are due the first day of each month (October - May).
- **Late fees of 5%** will be automatically processed to any account past due more than 20 days.
- An NSF cheque or a declined credit card will incur a \$35 service fee.
- Preferred methods of payment are by **Interac e-transfer, Interac debit or Post-dated cheques**. Visa or MasterCard payments can be made by arrangement however there is a **5% surcharge** on all credit card payments.

Student Withdrawal/Class Cancellations:

- A student may withdraw from a class with a 30 day written notice until December 15th, 2020. Any student who does not meet the withdrawal requirement will be charged for the next month.
- A student who must withdraw from classes due to a medical issue shall provide a Doctor's note and will be treated on an individual basis.
- If a class needs to be canceled we will make every effort to provide a substitute or reschedule it. This may include scheduling it on a school holiday or weekend and it is your responsibility to attend the makeup class as no refunds or credits will be given for missed classes.
- There are no refunds if a student misses classes, or after payment has been processed for the month.
- In the event of a studio closure, a studio closure in response to COVID-19 or any unexpected situation, classes will move online with Zoom. We will try our best to keep the schedule the same and payment will continue as usual.
- Monthly installments are non-refundable and are non-transferable as is payment for a student's last tuition payment.

Photography:

Additions to the Student and Parent contract:

- Parents are responsible for picking up their students on time. **Our waiting room and the kitchen remain closed.** Students with large schedules will be treated on an individual basis for exception.
