### **Tuition and class information:**

- Tuition is based on the number of **weeks of class instruction** from September - June. For your convenience, we offer a 10 installment equal payment plan:
  - A 45 minute class per week is **\$65 + GST** per month, a 60 minute class per week is **\$79 + GST** per month, a 75 minute class is **\$ 89 + GST** per month.
  - **Payment for Installment 1 and Installment 10 are non-refundable and due upon registration.**
  - **A non-refundable registration fee of \$40 +GST per dancer is due at registration.**

### **Important Payment information:**

- Payments for installments 2-9 are due the first day of each month (October - May).
- **Late fees of 5% will be automatically processed to an account past due more than 20 days.**
- An NSF cheque or a declined credit card will incur a \$35 service fee.
- Preferred methods of payment are by **Interac e-transfer, Interac debit, or post-dated cheques.** Visa or MasterCard payments are accepted however there is a **5% surcharge + GST** on all credit card transactions.
- A non-refundable recital costume deposit of \$50 + GST for each non-competitive class is due by Nov. 1, 2022. The deposit will be applied to the final costume fee of up to \$130.00 (depending on the class). Competition classes will be addressed in a separate document.

### **Student withdrawal/class cancellations and other information:**

- A student may withdraw from a class with a 30 day written notice until December 15th, 2022. Any student who does not meet this requirement will be charged for the next month.
- A student who must withdraw from classes due to a medical issue shall provide a Doctor's note and will be treated on an individual basis.
- If a class needs to be canceled we will make every effort to provide a substitute or reschedule it. This may include scheduling it on a school holiday or weekend and it is your responsibility to attend the makeup class as no refunds or credits will be given for missed classes.
- There are no refunds for missed classes, or after payment has been processed for the month.
- In the event of a studio closure, a studio closure in response to COVID-19 or any unexpected situation, classes will move online with Zoom. We will try our best to keep the schedule the same and payments will continue as usual.
- Monthly installments are non-refundable, and are non-transferable to another student.
- A year end recital will be held in June 2023.

### **Photography:**

- 360 Dance Project reserves the right to use photos and videos taken during any event (eg. classes, performances, workshops, etc.) for the purposes of instruction, advertising, or promotion of 360 Dance Project and its affiliated companies.

### **Additions to the Student and Parent contract:**

- Students shall arrive appropriately dressed and ready to join their class.
- Any student that engages in unsafe or disrespectful behavior will be required to sit out of class.
- Any concerns that need to be addressed should be discussed with teachers or staff directly, and outside of class time or social media.
- Parents are responsible for picking up their students on time, and notifying us of any absences.
