## **Tuition and Payment:**

Tuition is calculated based on the number of weeks of instruction from September to June. **Payment options include paying the full season upfront or choosing a 10-installment plan, with equal monthly payments due on the first of each month.**

- Class fees per month:
  - 45-minute class: \$69 + GST
  - 60-minute class: \$79 + GST
  - 75-minute class: \$99 + GST
- Payment details:
  - Payments for the first and tenth monthly installments are non-refundable and are due upon registration.
  - Monthly payments from October to May are due on the first of each month.
  - A late fee of 5% will be automatically applied if an account is overdue by more than 30 days.
  - We accept Interac e-transfer, Visa, and MasterCard. Credit card payments incur a 5% + GST surcharge.
  - A declined credit card will automatically incur a \$35 service fee.
- Registration and costume deposit fees:
  - Non-refundable studio registration fee: \$50 + GST at registration
  - Non-refundable recital costume deposit: \$50 + GST per class due at registration. The full costume fee, starting at \$130.00, is due on Jan 15/26.

## **Student Withdrawal & Class Cancellation Policies:**

- Students in non-competitive classes may withdraw up to November 30th. A written withdrawal notice must be provided to the studio at least 30 days before the desired withdrawal date. If less than 30 days' notice is given, or no notice is provided, the student's account will be charged for the following two months of tuition.
- Medical withdrawals require a doctor's note and will be considered on a case-by-case basis.
- Studio Closures: If the studio needs to close for an extended period due to unforeseen circumstances, we will assess the situation and move to online classes if applicable. Payments will remain the same, and attendance is mandatory.
- Non-refundable Fees: Full tuition payments, monthly tuition installments, registration fees, costume deposits and costume fees are non-refundable and cannot be transferred to another student.

### Photography & Media:

360 Dance Project reserves the right to use photos and videos taken during classes, performances, or workshops for promotional, instructional, or advertising purposes.

### Additional Student & Parent Information:

- Students are required to follow the dress code and arrive early for class.
- Students engaging in unsafe or disrespectful behaviour will be asked to sit out of class.
- Any concerns should be addressed directly with teachers or staff privately, outside of class or the foyer, or via social media.
- Please notify the studio of all absences or if a dancer will be late for class. No refunds are given for missed classes.
